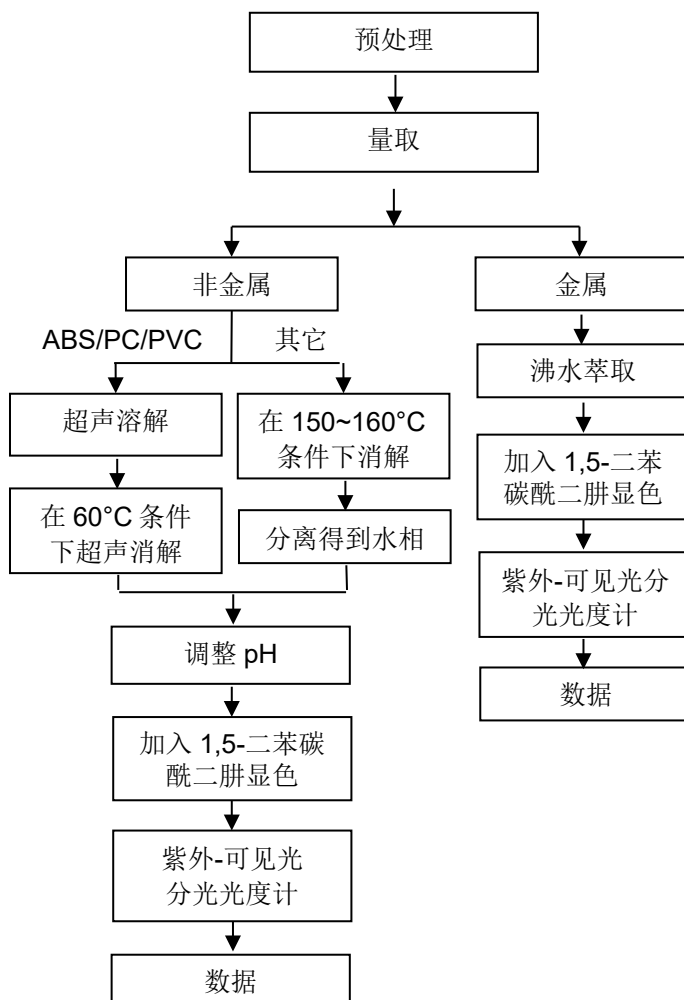

## 元素检测流程图

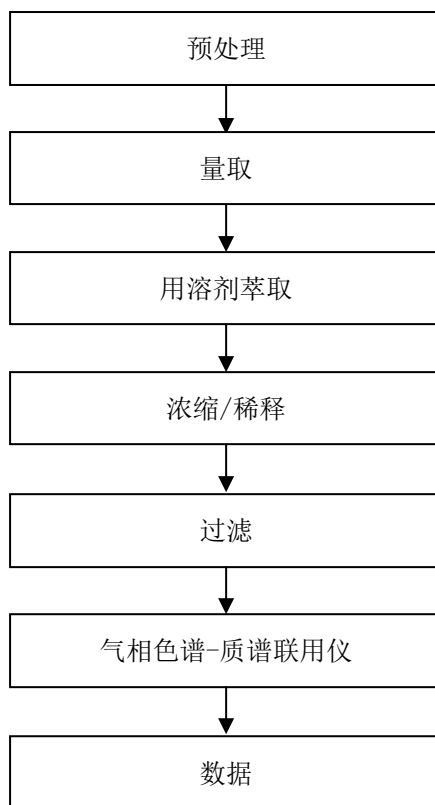

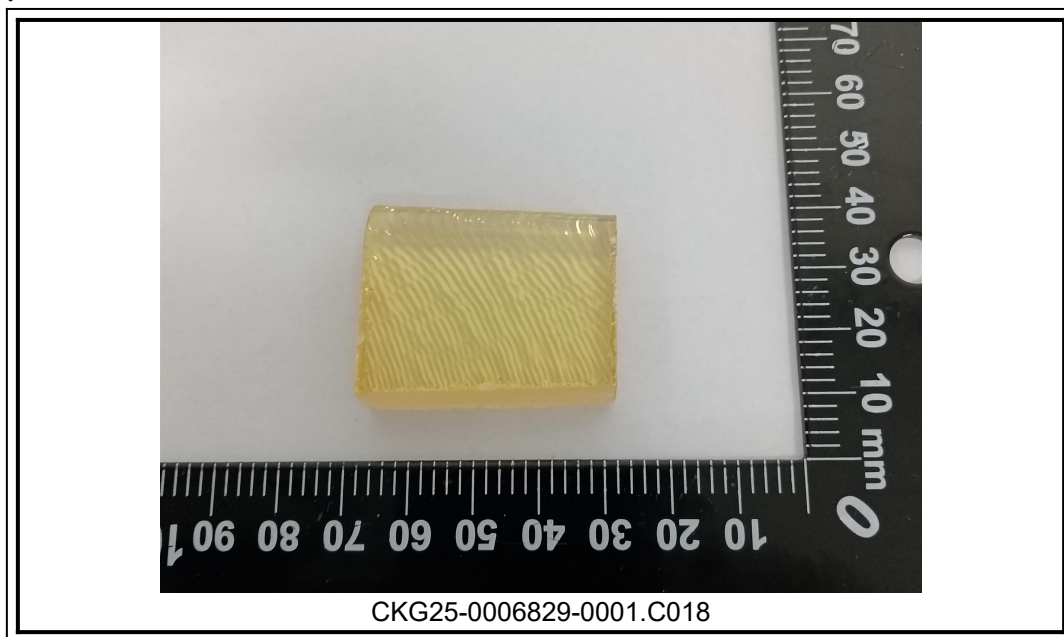
